IN MEMORY OF CAROL HARRELL



Carol Sue Harrell, age 74, passed away on Friday, October 17, 2025 surrounded by her family. A memorial service was held at Carlisle Funeral Home in Tarboro, NC on October 25th. Carol is survived by her son, Michael Harrell; daughter-in-law, Catie Harrell; grandson, Aidan Duncan; mother, Daisy Ritchie; siblings, Sharon Keefe, Eddie Ritchie, and Mike Ritchie; and her beloved pets, Chop and Sunshine.

Carol was a loving mother, sister, daughter, and grandmother whose quiet strength and gentle presence left a lasting impression on those closest to her.

Carol was a devoted member of Grace Chapel Church, where her faith guided her throughout life. For 37 years, she worked at Carolina Telephone and Telegraph Company, where her reliability and kindness earned the respect of her coworkers and friends. In her younger years, Carol was a member of the Jaycee's, and she has been an active Carotel Pioneer Club and Tar Heel Chapter member for many years.

Carol joined CT&T in Tarboro in 1971 where she worked in the purchasing department. She later worked as a plant clerk, Division Head Secretary, Budget and Results Analyst, Regional Systems Administrator, Business Analyst and Customer Service Engineer. From there she moved to Greenville's Network Switching Department as a REM Analyst, a Systems Administrator and a Customer Service Engineer. Carol retired from Embarq in 2008.

Carol joined Carotel in 1987 when 15 years of service was required. She was a dedicated Carotel Pioneer member for 38 years. Carol attended the annual Carotel convention for at least 25 years and she played a key role in coordinating that event. She has served the club as Director, Vice President, and President, and was also very involved with the Tar Heel Chapter Pioneer Club. Carol also served as scholarship committee chairman for both the Carotel Pioneer Club and the Tar Heel Chapter for many years. Her role in that capacity was not an easy one. She reviewed all forms to ensure the applicants met the qualifications, and then she mailed qualifying forms to committee members who rank the applicants based on established criteria. The committee then reviewed rankings and the applicants are notified. Carol then coordinated presentation of the scholarship to the recipients. Carol also served as treasurer for both the Carotel Pioneer Club and the Tar Heel Chapter, a role that is one of the most demanding and time-consuming position on the board.

Carol's hobbies included gardening, feeding and watching birds, and she particularly enjoyed watching the shenanigans of her back-yard hummingbirds. Carol was thought of by some of her Pioneer friends as an observer, a pensive sort. She was once asked during an interview what she would choose as her super-power, and her answer, not surprisingly, was "Sensitivity." Carol went on to explain that she wanted to know how other people are feeling. You can be sure Carol was not one to call attention to herself, but she was there and did whatever anyone needed of her. A lot can be accomplished when you listen and observe, as Carol did.



Did you know....

The term "sock hop" came about because in the 1950's when social dances were held in the school gymnasiums. The dancers danced in their socks because street shoes were forbidden on the gymnasium floors. Even tennis shoes were not allowed at the dances because someone invariably would sneak in wearing conventional shoes and scratch the hardwood floor. Chaperones were often the worst culprits of all, so even they were required to wear socks unless they observed from the bleachers.

IN CASE YOU'RE PUZZLED

TAR HEEL CHAPTER

As a member organization of the national Independent Telecommunications Pioneer Association (ITPA), Carotel Pioneer Club is one piece of a large puzzle. Several of our members have asked exactly how we fit into that puzzle with regard to the Tar Heel Chapter and the national ITPA. The ITPA Charitable Foundation, Historical Foundation, Telephone Museum and Hall of Fame, as well as other state chapters and clubs are also important pieces of our puzzle. Just how all these pieces fit together may not be crystal clear. This article will provide clarity on Carotel's piece of the puzzle.

The ITPA was created by and for the independent telecommunications industry in 1920 as a national volunteer organization. State and regional clubs and chapters were subsequently formed, and through national and localized efforts, Pioneers have been serving their communities continuously for 105 years on behalf of telecommunications companies.

At its peak, the ITPA consisted of hundreds of clubs with nearly 10,000 members. To best serve its members and their communities, the ITPA's organizational structure was divided into regions. State chapters were established within each region, and local clubs, such as Carotel, were assigned to their appropriate chapter and region. Regional Vice Presidents, known as RVPs, report directly to the national ITPA President, and they assist the chapters and clubs they support with a number of issues. They also share information from clubs and chapters with the national ITPA board of directors and likewise, share information from the national level with the board of directors of each club and chapter.

Each club has its own slate of directors and officers, and is required to submit the required annual documentation to the IRS and the national ITPA to retain non-profit status. Likewise, the officers and directors of each chapter are required to submit their own annual reports to the IRS and to the national ITPA.

The Carotel Pioneer Club was formed on July 1, 1971 under the authority of the Tarheel Chapter. The club's original membership charter covered the territories served by Carolina Telephone and Telegraph Company headquartered in Tarboro, NC. Carotel is in the Tarheel Chapter, along with independent ITPA members who were previously members of the disbanded Lexington Pioneer Club.

The Tarheel Chapter, which also has its own set of officers and board members is in Region 2 of the ITPA. The Buckeye State Chapter (Ohio), Palmetto Chapter (South Carolina), National Capitol Chapter (Virginia, Washington D.C.), and the CenturyLink Pioneers of Georgia (no Chapter Affiliation) are also in Region 2. Page 13 includes a list of the regions, clubs, and chapters currently affiliated with the national ITPA.






IN CASE YOU'RE PUZZLED (CONT'D)

The only requirement to be a "member" of a state chapter is to pay dues into a club that tiers to that chapter or to join the chapter directly and pay membership dues without a club affiliation. A number of Carotel Pioneer Club members are active not only at the state chapter level but are also active with the national ITPA. Several Carotel club members hold officer and/or director positions at the state and national level, and also serve on the boards of the Charitable and Historical Foundations. Carotel Pioneers who are active at the state and national levels enjoy working together with Pioneers from other clubs and chapters to serve people throughout the United States. In doing so, great Pioneer friendships have formed and have grown stronger throughout the years.

Our annual Pioneer membership dues help the national and local branches of the ITPA as we continue making a difference in our communities and across the nation. Twenty percent of the \$30 annual membership fee is sent to the club/chapter of dues paying members, conditional upon the club/chapter having submitted the required IRS 990 reports each year and filing an annual report with the ITPA. Annual reports are due every fall and are submitted to the appropriate Regional Vice President (RVP). Once the RVP approves the annual reports and forwards them to the National Office, the portion of the membership fees allocated to the club/chapter are processed.

The portion of our membership dues that are retained at the national level contributes to, but does not fully cover, our national operating expenses. Member attrition over the years, combined with a decline in corporate sponsorships, means that membership fees and donations to our foundations, are more critical than ever before, for us to continue operating at a local and national level to make a difference across the nation.

Now that you know all about how our local clubs and state chapter puzzle pieces fit together, let's discuss how the Charitable Foundation and Historical Foundation fit into our Pioneer Puzzle. Keep in mind that the Independent Telecommunications Pioneer Association Inc. is registered with the IRS as a 501(c)(10) tax exempt organization. The Charitable Foundation and the Historical Foundation are registered separately with the IRS. They operate independent of the national ITPA, although Pioneers who are affiliated with clubs and chapters across the nation serve as officers and directors of those organizations.



IN CASE YOU'RE PUZZLED (CONT'D)

The Charitable Foundation is registered as a 501(c)(3) tax exempt organization. This organization accepts donations that are then distributed to various 501c3 non-profit organizations. The Charitable Foundation collects and distributes tax-deductible donations to charitable causes and works with the ITPA to support the volunteer efforts of local phone companies on a national level. inception, the Charitable Foundation has supported many programs, such as Ronald McDonald Children's Charities, Children's Shriners Hospitals, St. Jude Children's Research Hospital, the American Red Cross, and the American Health Assistance Foundation. Through donations made by ITPA members, the Charitable Foundation donates annually to a program that supports our heroes injured in battle, and to the Alzheimer's Association, hoping to one day find a cure for this disease that affects more than six-million Americans. The Charitable Foundation also provides emergency disaster relief grants to clubs, chapters, and organizations to assist victims of natural disasters.



The Historical Foundation is registered as "Independent Telephone Historical Museum and Hall of Fame Foundation Inc." with the IRS as an exempt 501(c)(3) private foundation. The ITPA's Historical Foundation is the vehicle through which the ITPA preserves the telecom industry's rich history at the Telephone Museum in Hinesville, Georgia and through which telecommunications Pioneers are inducted into the ITPA Telephone Hall of Fame. What's up with the mascot?

The ITPA Mascot represents a long-standing ITPA tradition. Every year during the annual spring assembly when the incoming president takes office, the newly elected president introduces a new mascot. No sooner than the new mascot is presented than someone kidnaps the mascot, and the new president won't see his or her mascot until the following year's annual assembly.

During the year, the mascot travels all over the country with various Pioneers, attending club and chapter events and even vacationing with Pioneers. When the incoming president announces the new mascot, they also announce their charity of choice for the coming year. At the end of the year, at the next assembly, the kidnapped mascot is reunited with the president, but only after the president begs for money from the convention attendees to meet a ransom demand. The ransom amount is generally set by the next incoming president. Most often, there are strings attached to the money that assembly attendees are willing to donate towards the ransom.

Conditions such as doing push-ups, skipping rope, dancing, singing, or any number of silly challenges must be undertaken before the money is handed over to the president.

When all is said and done, the money collected for the mascot's ransom is donated to that president's charity of choice and the outgoing president is temporarily reunited with their mascot. The union is temporary because the mascot will ultimately find a home at the ITPA Telephone Museum where a number of mascots are on display at any given time.
